



## Artist Contract, Terms & Conditions

This Contract is between the artist listed above and the Nashua Area Artists' Association in exchange for mutual benefits shared by both parties, the parties agree as follows:

1. I, the Artist, agree to allow the Nashua Area Artists' Association to sell my artwork for commission. I confirm that I am the sole creator and owner of the submitted artwork. I also confirm that the submitted artwork is not derived from the work of another artist and was not completed as part of an instructional class.
2. I, the Artist, acknowledge that exhibition space is limited. Artwork will be displayed as space limitations allow. The artist will be contacted to pick up any work we are unable to display. Pickup and delivery and removal deadlines must be strictly adhered to. Work left beyond the pick up date will be subject to a \$5 per day holding fee. Work left 30 days beyond the pick up date will be considered abandoned and will become the property of the NAAA. In the event that such work is sold, I shall not be entitled to any of the proceeds of such sale.
3. I, the Artist, reserve copyright, including all reproduction rights, except for photographs made to advertise and/or to memorialize the exhibition.

- I give consent to use images of my artwork for publicity for the exhibition as a whole. I understand this may include use of photographs on the association website and social media.
- I do not wish for my work to be photographed and used for publicity.
4. I, the Artist, acknowledge that the Association will make every effort to ensure the safety of the Artist's work and that the exhibition space is a public place and the safety of the artwork cannot be guaranteed. I, the Artist, am responsible and, therefore may choose to insure my work for the length of the exhibition. I cannot hold the Association liable for any loss or damage.
  5. In order to provide this opportunity for artists to display, there may be a fee. In order to maintain the gallery and the NAAA, there will be a flat commission of 30% on all sales. No items under \$3 will be accepted and all items must be priced in dollar values only, no cents.
  6. I, the artist, understand that there is a gallery sitting requirement for all ArtHub exhibitors. Artists exhibiting at the ArtHub Gallery must gallery sit twice per rotation. If I am unable to fulfill this commitment, I agree to pay a \$15 fee for each missed gallery sitting session.
  7. I, the Artist, acknowledge understanding of the Eligibility, Entry Information, Entry Procedures, Artist's Responsibilities, and Fees and Commission as presented to me. I acknowledge reading and understanding the Policy and Guidelines for Displaying at the ArtHub and will abide by said Guidelines and Policies.
